- **Revised major requirements:** (67 semester hours) Students seeking a major in Industrial Engineering Technology must complete 67 semester hours, within the 120 semester hour Industrial Engineering Technology curriculum, which include Electronics Engineering Technology 1300-1301, 1311, 1320-1321; Industrial Engineering Technology 1400, 1700, 1800, 2020, 2040 2790, 3150, 3510, 3570, 3740, 3900, 4700, 4720, 4730, 4820, 4890, 4940 or Electronics Engineering Technology 4940, 4960, or Electronics Engineering Technology 4950; and six hours of electives from any Industrial Engineering Technology or Electronics Engineering Technology courses.
- **Curriculum:**
  - 2<sup>nd</sup> year:
    - Delete: MATH 2050
    - Add: IET 2040
  - 4<sup>th</sup> year:
    - Add IET 4940 as an option to EET 4940

D. Make the following changes to **Electronics Engineering Technology (141) program:**

- **Revised major requirements:** (46 semester hours) Electronics Engineering Technology 1300-1301, 1320-1321, 1330-1331, 2320-2321, 2330-2331, 3310-3311, 3340-3341, 3360-3361, 4300-4301, 4390, 4940 **or Industrial Engineering Technology 4940**; Industrial Engineering Technology 1400, 1700.
- Make the following revision to the **Electronics (141A) concentration:**
  - (20 semester hours): Electronics Engineering Technology 4310-4311, 4350-4351, 4950 **or Industrial Engineering Technology 4960**; Industrial Engineering Technology 2790, 3740; and three additional hours of technical electives<sup>1</sup>.

    - Add: IET 1080 as an option to CSC 1060
  - **4<sup>th</sup> year:**
    - Add: IET 4940 as an option to EET 4940
