Call to Order

Dr. Vickie Gentry called the meeting to order with quorum noted. She introduced the agenda, which included the proposal for the new Doctorate program.

Agenda Item I: The Graduate School

• Catalog update: Make the following change to the Minimum and Maximum Course Load section:

During a regular (16 week) semester, the full-time course load for a graduate student is 9 hours (6 in a summer session). The maximum amount of hours allowed during a regular 16 week semester is 16 hours. However, the student must have approval from the major professor/advisor and the Dean of the Graduate School. A maximum of 9 hours may be allowed during a 12 week summer session, and a maximum of 8 hours during an 8 week summer session with the approval of the major professor/advisor and the Dean of Graduate School.

Lindsey moved and Melder seconded to approve Item 1 with the following revision:

Minimum and Maximum Course Load

During a regular 16-week semester, the full-time course load for a graduate student is 9 hours; the maximum number of hours allowed is 12 hours. Any additional hours requires approval from the major professor/advisor and the Dean of the Graduate School. During an 8- or 12-week summer session, the full-time course load for a graduate student is 6 hours; the maximum

number of hours allowed is 9 hours. Any additional hours requires approval from the major professor/advisor and the Dean of the Graduate School.

Motion passed unanimously.
